



SPECKS & SPOTS RULES & REGISTRATION

All anglers must be registered by 6 p.m. Friday, June 7th, 2024.

Last weigh in will be at Bay Marina: Saturday, June 8th at 5 p.m. Armbands are required at weigh in.

Awards ceremony will follow close of scales. Participants are responsible for the disposal of their fish. Weight of fish will be in pounds and ounces.

In the event of a tie, the first fish weighed is the winner.

THE WEIGHMASTER'S DECISION IS FINAL. Fish which appear to have been harpooned, frozen, mutilated, shot, or netted may be refused. All fish are subject to test by Torrymeter.

In case of inclement weather, four (4) hours of fishing without small craft warnings will constitute a complete tournament.

Participants enter at their own risk. Neither the tournament nor any Person connected with the tournament shall be liable for any loss, damage, negligence, harm, or injury to anyone for any reason.

Anyone found to be in violation of the tournament rules will be disqualified.

All fish entered for prize consideration must comply with all fishing laws of the State of Mississippi.

All contestant(s) found to be in violation of this tournament or previous determined to have violated any other fishing tournament rules shall result in disqualification of the contestant(s), and none shall be eligible to win any prizes.

Anyone wishing to protest a decision by the Weighmaster must enter the protest in writing before 5 p.m. on Saturday, June 8th, 2024. All written protests will be considered by a protest committee of no less than four (4) tournament directors. The protest must be accompanied by a \$100 deposit. The decision of directors is final.

Participants shall be eligible to win only one prize per fish category. (Winners are required to fill out 1099 form.)

MANDATORY: At least person from each boat MUST attend Captains' meeting on June 7th, 2024, at 6 p.m. at Bay Marina in Bay St. Louis, Mississippi.
